**Sydney Football Stadium Redevelopment – Precinct Village and Carpark (SSD-9835)
Out-of-hours Work Application, Condition C5(a) and C6**

Dear Ms O'Neil

I refer to your Out-of-hours work (OOHW) application submitted to the Planning Secretary for approval in accordance with condition C6 of SSD-9835. I also acknowledge and thank you for your response to the Department's comments for further clarification.

The OOHW application proposes to demobilise a piling rig from the Precinct Village and Carpark (PV&C) site outside approved construction hours on 1 night between Monday 8 September 2025 and Friday 12 September 2025. Restrictions on the daytime use of roads for oversized deliveries within the City of Sydney mean that this type of delivery may only occur during night-time periods.

The Department has carefully reviewed the OOHW application and is satisfied that you have provided appropriate justification for the works in the circumstances.

Accordingly, as nominee of the Secretary, I approve the request to undertake the proposed OOHW under condition C6 of SSD-9835, subject to the following:

1. OOHW may be carried out to demobilise a piling rig from the site, and unload the delivered plant, outside approved construction hours between 1am and 5am only on 1 night between Monday 8 September 2025 and Friday 12 September 2025;
2. The draft OOHW notification must be finalised and distributed to the nearby community within 7 to 14 calendar days prior to the OOHW commencing;
3. In finalising the draft OOHW notification noted in point 2 above, the notification must include, but not be limited to, the following: a. A clear community complaints hotline phone number, email, and/or other mechanism, which residents may use should they wish to make a complaint during and after the OOHW;
4. OOHW must be carried out in accordance with the OOHW application form prepared by BESIX Watpac dated 14 August 2025 and the currently approved Construction Noise and Vibration Management Sub-plan (CNVMSP) (Rev 6 Issue 7) prepared by Pulse White Noise Acoustics Pty Ltd dated 3 July 2025;

5. All recommended noise and vibration mitigation and management measures proposed in the OOHW application and CNVMSP must be implemented for the OOHW; and
6. All relevant employees/staff must be briefed for HSE requirements including effective supervision whilst conducting the proposed OOHW.

Please make the relevant OOHW documents including this letter available for public access on the project website as per condition A36.
